Lieutenant Governor of Saskatchewan Meritorious Achievement Award

Purpose

The purpose of the Lieutenant Governor of Saskatchewan Meritorious Achievement Award is to recognize a distinguished member of the consulting engineering/geoscience industry. Consideration will be given to the individual's contributions to business, society, and the Association of Consulting Engineering Companies - Saskatchewan.

Eligibility

1. A Saskatchewan resident who demonstrates outstanding achievements and contributions to the consulting engineering and/or geoscience industry in Saskatchewan, whether technical or managerial in nature.
2. Candidate should be from an ACEC-SK Member Firm or recently retired from an ACEC-SK Member Firm.

Nomination Procedures

1. **Who May Nominate:** Nominations may be submitted by any ACEC-SK member firm.
2. **Number of Nominations:** There is no limit to the number of nominations a firm may submit.
3. **Nomination Validity:** All nominations remain active and will be considered for a period of three (3) years from the original submission date.

Submission Requirements

A complete nomination package must include the following:

1. Summary Document

A written summary that clearly demonstrates why the nominee is deserving of this prestigious recognition. This document must reference and integrate the supporting materials included in the submission.

2. Supporting Documentation

Your nomination must include the following components:

a. Candidate's CV (maximum 6 pages)

The CV must outline the nominee's accomplishments in the key evaluation areas:

- Leadership
- Public profile
- Notable achievements
- Volunteer initiatives (e.g., learned societies, industry associations, community service)

b. Essay (maximum 4 pages)

An essay highlighting how the nominee exemplifies qualities worthy of this award, including:

- Memberships
- Professional involvement
- Community involvement
- Career achievements

The essay must also include:

- Name, title, company, telephone number, and email address of the individual providing the document.

c. Testimonials / Letters of Support (minimum 2, maximum 5)

Letters should provide insight into the nominee's impact, character, and contributions. Each letter must include:

- Name
- Title
- Company
- Telephone number
- Email address of the writer

e. Completed Nomination Form

The official ACEC-SK nomination form must be filled out in full.

f. Professional Photo

A current, **high-resolution (4"x6" colour, JPG format, 300–600 dpi)** head-and-shoulders photograph of the nominee.

Documentation demonstrating candidate's accomplishments in their profession, community and industry/business, that highlight and will be evaluated as follows:

- candidate's leadership
- public profile
- specific achievements
- volunteer initiatives (e.g. learned societies, industry/business associations, etc.)
- Other endorsements, if available (e.g. media reports, press releases, citations etc.)

Please note that the quality of the submission provide will be a factor in evaluation.
